## CHAMPIONS & CHAMPIONSHIP POINTS

**SECTION 1:** A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

**SECTION 2:** The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs Competing:	1	2	3-5	6-9	10-12	13 or more
POINTS ALLOCATED*	0	1	2	3	4	5

\*Includes the dog awarded WINNERS

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder):

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

## GENERAL INFORMATION

1. To comply with instructions issued by the Canadian Kennel Club we will be unable to accept, cancel or substitute an entry reaching our Show Secretary after the closing date. Moving class dogs to specials is permitted. An error in the class, date of birth or sex may be amended on the entryform up to one hour before the start of the show.
2. All entry confirmations and Judging Schedules will be sent as soon as possible after entries close.
3. It is YOUR RESPONSIBILITY TO VERIFY the receive of any electronic entries prior to the advertised closing date. A valid means of payment must accompany all entries.
4. All exhibitors should review Section 4.1-Judges-General, sub sections 4.1.3, 4.1.4 & 4.1.5 of the CKC Conformation Rules and Regulations.
5. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made.
6. It is the exhibitor's responsibility to have the dog in the ring when the dog's class is called to be judged.
7. The Wildwood Kennel Club, its officers and associates will use due care & diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or misfortune, to either dogs, exhibitors, or patrons. If because of riots civil disturbances, or other acts beyond the control of the management, and it is impossible to open or complete the show, no refund of entry fees will be made.
8. The Show Superintendent will be in complete charge of the show and/or trial which will be governed by the rules of the Canadian Kennel Club (CKC)
9. SHOW PRECINCTS - The Show precincts shall consist of all areas set out for rings, and 10' around
10. Judging will commence no earlier than 8:00 am each day. An later starting time may be specified in the judging schedule.

## ATTENTION ALL FOREIGN EXHIBITORS

To obtain an ERN simply do the following:

Send a photocopy of the dog's registration certificate reflecting current ownership - with a written request for an ERN. Include full payment in the amount of \$62.40 plus tax. Accounts may be paid with personal or business cheque, money order, Visa or Mastercard. For Non-Members please note that if paying by cheque, the cheque must be certified. Non-residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates. Provide us with your full return address. -Faxed requests will be accepted. Please include your VISA/MasterCard number, expiry date, cardholder's name and signature. An ERN must be obtained within 30 day of obtaining points, awards or scores to avoid cancellation. ## **Covid-19 Safety Protocol for Wildwood KC 2021 Shows**

**If you cannot comply with these rules Do Not Enter or Attend!**

THERE WILL BE A ZERO TOLLERANCE POLICY ON COVID-19 VIOLATIONS, INCLUDING NOT WEARING A MASK OR NOT SOCIAL DISTANCING WHEN IT IS POSSIBLE.

**Waiver must be signed**, by Club Members, Judges, Ring Stewards, Exhibitors, Owners, Handlers, Breeders, Assistants, Volunteers, Vendors, Family Members, Friends etc.

Contact tracing information must be provided for all who attend (name & phone number)

**Masks Must be worn correctly over mouth & nose this is (Mandatory)** by Exhibitors, Judges, Stewards in the rings during judging.

Each ring will have **an Entrance, an Exit and Social Distancing Markers**. Exhibitors will pick up their placement ribbons as they exit the ring, **NO RECYCLING** of ribbons.

**Masks Must be Worn correctly over mouth & nose this is (Mandatory)** under the tents/pavilion, in Washrooms, in any other location where 2 meters - 6ft cannot be maintained.

**Social Distancing 2 meters-6ft this is (Mandatory)**

in the rings, under the tents, adjacent ring areas, at the Show Secretary Table/Set-up, at the Photographers booth.

**At all times, Upon arrival to the venue**, a Covid 19 screening (series of questions) will take place. You must remain in your vehicles as you answer these questions.

In ADDITION as STATED BEFORE your WAIVER MUST BE COMPLETED AND SIGNED . The GATE KEEPER will collect these and give you a wrist band.

## **ADDITIONAL INFORMATION**

**The Dog Show is NOT OPEN to the General Public.**

**Show Site Access Process:** Waiver is to be handed into the club upon arrival at show site, attendance wrist band will be provided at this time only.

The Club will provide hand sanitizing stations, there will be a “limited” supply of masks in case someone needs one.

Grooming tables used in the ring will be cleaned frequently.

No Public Catalogue will be available, know your numbers when picking up armbands.

Be self-sufficient: bring sanitizer, bring personal use masks.

Do not leave personal belongings at ringside.

Do not leave masks, gloves, water bottles, litter, etc. behind, dispose of these items in the garbage bins.

Avoid shaking hands, hugging, or other physical contact.

Avoid touching dogs that are not your responsibility.

Avoid common use pens/pencils – bring your own writing instrument.

- Dogs cannot be groomed outside of your vehicle anywhere on site.
- Exhibitors will be lined up in groups in your vehicles to go to ring area to show your dogs. Vehicles will be escorted to the ring area by a pilot . No exceptions!
- We need 100% cooperation from everyone.
- Any deviation from 100% compliance will result in ejection from the show without refund.
- The Wildwood Kennel Club, its members and volunteers thank you for helping us in these trying times.
- The health department, humane society as well as bylaw officers may arrive at the venue at any time without notice.

I fully attest to the best of my knowledge that I do not have Covid-19 at the time of attending this show. I also attest that I have NOT been in contact with or exposed to any known carrier of Covid-19 within the past 14 days. I agree that I am attending the Dog Show entirely at my own risk and take full responsibility for my own health and safety during this event. I will follow the Wildwood Kennel Clubs rules, requirements, procedures, protocols and guidelines to reduce any exposure or the possibility of contracting or spreading the virus.
