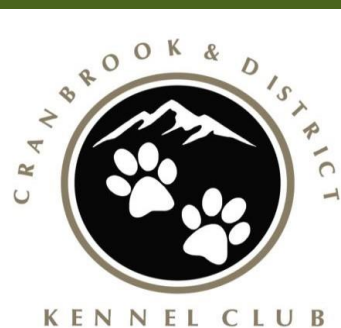

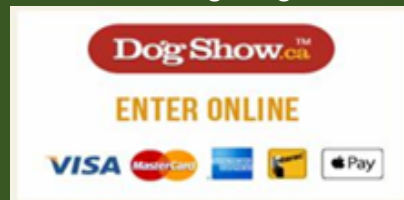

#### **Terry Carter, AB, Canada**



My first dogs were 2 smooth Fox Terriers that my grandfather gave to my brother and me. But as we lived on a farm, we had Border Collies and later Australian Cattle Dogs. Working dogs.

Gary had 3 OES when we married so that was my beginning with the dog fancy. Like most people I started taking obedience classes and then graduated to matches and then dog shows.

We had a successful breeding program with our Old English, and I enjoyed showing them all over N. America. We were fortunate to win Specialties in Canada and the U.S. and dogs that we exported won in other countries.

We were involved with Chows for a few years and most recently we have had Norfolk Terriers and have bred them for 4 generations.

I began judging in 1988 and have been lucky to have my hands on some really lovely dogs in that time. I have visited many countries and met many interesting people that I would never have met if I had not been judging.

In my other life I was a Registered Nurse and the mother of 2 boys and now the grandmother to 4 children

#### **Margaret Jones, BC, Canada**



I am a retired Health Care Administrator who has been showing and training dogs since 1965, when I obtained my first Irish setter. Since then my husband and I have shared our home with Irish Setters, Cairn Terriers, Boxers and a number of different breeds including, Doberman Pinschers, a Great Dane, Afghan Hound and a Tibetan Mastiff.

As a small breeding kennel we raised and bred Irish Setters, Boxers and Cairn Terriers under the Kian Prefix and exhibited them to Group, Specialty and Best in Show wins.

I gained many Obedience titles with our Irish Setters and Boxers. Cairn terriers do not excel in the Obedience ring but they love to work at Rally, Scent detection and Earth sports.

As an All breed Judge I have been privileged to judge many times at All Breed and Specialty shows in Asia, Australia, Europe, South Africa, South America, U.K., Canada and USA.

I am a Life member of the Canadian Kennel Club and served as a Director of the Canadian Kennel Club Board from 2003-2011. During that time I served on several Committees and Co-Chaired the CKC Charity Dog Show

I am Past President of the Canadian Dog Judges Association and Immediate Past President of the BC All Terrier Club, Cairn terrier Club Canada, and Tyee Kennel Club.

I am still actively involved with local and National Breed Clubs.

### Virginia Lyne, BC, Canada



Virginia Lyne started in the dog show world in 1953 with a black American Cocker Spaniel who taught her a great deal about stubborn and demanding dogs! In 1960 following a year in the UK she returned with an English Cocker from the Lochranza Kennels and she started breeding under the Ranzfel prefix.

Many outstanding Best in Show dogs resulted over the years

Actively involved in Obedience as a trainer, instructor and subsequently judge she was approved to judge all obedience classes in 1968 and completed approval to judge the Sporting Group in 1969.

In 1979 she completed All Breed judging approval.

Judging regularly across Canada and the USA as well as many International appointments, Virginia knew this was to be her passion totally immersed in the world of purebred dogs with a particular

interest in Judges' Education.

50 years ago she was privileged to exhibit English Cockers at the 1973 Inaugural show of the Cranbrook Kennel Club.

She is both humbled and proud to be invited to return to judge General Specials on this 50<sup>th</sup> anniversary occasion.

### Marg Moran McQuinn, SK, Canada



I got my first Scottie in 1973 and showed him in obedience, scent hurdle racing and conformation. I eventually imported my foundation bitch from Great Britain in 1976 who enabled me to breed Canada's #1 and #2 all-time top winning Scottish Terriers that won about 40 Bests in Shows between them. One was Top Terrier in Canada and the other won BOB at the American National Specialty twice. Our last Scottie passed away in 2017 at the ripe old age of almost 16 years so no dogs currently, but you never know... I also owned and showed Standard Poodles, mostly in obedience.

I am a life member of the Canadian Kennel Club, the Regina Kennel and Obedience Club (where I taught obedience and show handling for many years), the Scottish Terrier Breeders and Exhibitors Association (Great Britain) and a regular member of the Scottish Terrier Club of American. In fact, the latter awarded me a special award for outstanding service to the club for my work doing the quarterly national magazine and making it profitable once again. After I retired, served a term on the Canadian Kennel Club Board of Directors, and was Chair of the Canadian Kennel Club's charitable foundation. I was also a regional rep for the Canadian Dog Show Judges Association.

I began judging quite a few years ago – strictly terriers – but after recently retiring from a crazy but interesting job, decided to apply for some additional groups.

A Canadian winter-phobe, my husband and I part of the year in Cozumel, Mexico where I scuba-regularly (and moderate an international internet discussion group on the topic). I am also a volunteer at the Cozumel Humane Society and have volunteered for the Crux Roja (Red Cross) and a horse rescue on the island. I also practice and teach yin yoga in Coz. It's supposed to help me relax, among other things.

I plant a big, productive garden in Canada and love to cook using its bounty from my collection of almost 350 cookbooks. Sushi is my favourite.

### Peggy Gutierrez-Ortero, Mexico



**My activity in the dog fancy:** I was born in a very dog oriented family, that included my parents (Mexican and Venezuelan) and a twin sister. Although at first love for dogs was not focused in purebreds and show dogs, soon the hobby became passion for all the family, sharing breeding, showing and caring for all our house dogs, at the time Am. Cockers and Wire Fox Terriers. My sister and I were very competitive junior handlers during our young years. Later on Dalmatians were added to our kennel and in 1962 we moved to Mexico, bringing with us 2 females, Am. Cocker and a Dalmatian, which became our breeding bitches in the new country. At the beginning of the 70s, we started breeding Basset Hounds, passion that lasted over 35 years till the death of my



last dog in 2010. In 2006 I received as a gift my first Miniwire Dachshund and from then on, I have done limited breeding and showing.

I am an architect by profession, having focused my first working years in designing and construction. Later on and till my retirement in 2008, I worked at the Appraisal department of a Government owned bank. At the time, being happily retired, I devote my free time (all day, actually) to my family, my dogs, judging dog shows, reading and some hand crafts. I belong to the Federación Canófila Mexicana (Mexican Kennel Club) since I arrived in Mexico in 1962. I was president of the Mexican Basset Hound Club during the 80s. Currently, I belong to the Basset Hound Club of America and the Dachshund Club of America, having attended in the last years to their National shows in different USA cities. I was ring steward for many years and I have been international FCI all breed judge for 35 years.

I have judged specialty and all breed shows in all the American countries (except Paraguay) as well as in Australia, New Zealand, Thailand, Japan, Indonesia, Malaysia, India, Ireland, Russia, China and South Africa. In 2015 I was honored by being appointed to judge the Wire variety at the DCA National in USA.

#### **Roberta Parish, BC, Canada**



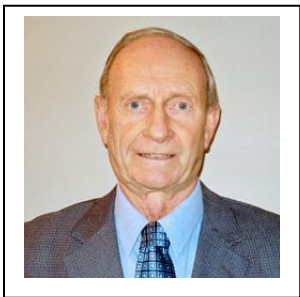
As a child I was dog crazy and my poor parents were blessed with a series of rescues at my instigation. I did not become involved in pedigreed dogs until the mid-1980s, after I finished my doctorate in population biology. I started with Dobermans Pinschers and exhibited in conformation and obedience. I bred under the *Haefen* prefix.

In 2000, I began to look for a sighthound breed. I was fortunate that one of the most famous saluki breeders, Hope Waters, had moved to the west coast of British Columbia and was willing to educate and mentor. My first Burydown saluki introduced an appreciation of both the beauty and functionality of the breed. I continue to breed, exhibit in conformation, and course my salukis.

I began apprenticing judging in the late 1990s and started judging in 2012. I currently hold Canadian Kennel Club (CKC) licenses for the Working, Hound, and Toy Groups. I have judged across Canada and in the USA.

I was an active member for many years in one of the oldest all-breed clubs, Victoria City Kennel Club, serving as Show Chair from 2012 to 2020. I also belong to the Vancouver Island Dog Judges Study Group, which organises educational events for dog judges. I am Treasurer for the Vancouver Island Lure Coursing Association, Past President of the Saluki Club of Canada, and a member of the Genetics and Medical Committee of the CKC.

#### **Wayne Thompson, BC, Canada**



Mr. Thompson has been a member of CKC since 1973 and an All Breed Judge since 2007. He has judged in the USA, New Zealand, Australia, China South Africa, Indonesia, Tasmania and Mexico.

He has bred English Springer Spaniels under the “Worath” kennel name for many years. He has also owned a Doberman Pinscher, Beagles and Smooth Fox Terrier. He also handled most other breeds throughout the years. At present, Mr. Thompson is a retired automotive technician, His hobbies include golfing, curling and travel.

## **GENERAL RULES GOVERNING THESE SHOWS**

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from the CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **MOUNTAIN DAYLIGHT TIME.**
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. If you are unable to attend due to COVID or any other ailment, it is your responsibility to find an alternative handler for your dog. No refund will be given.
- 14 **CDKC has a zero tolerance** of abuse of any description involving any person involved with the CDKC shows, including spectators. individuals will be asked to leave the show grounds premises immediately and for the remainder of the event (no refunds).

## **CLASSIFICATION-CONFORMATION**

### **REGULAR CLASSES**

**JUNIOR PUPPY** - 6 months & under 9 months on the day of the show

**SENIOR PUPPY** - 9 months & under 12 months on the day of the show

**12-18 MONTH CLASS** - for dogs 12 months of age and under 18 months of age on the day of the show

**CANADIAN BRED** - for dogs born in Canada, Champions in any country excluded.

**BRED BY EXHIBITOR** - shall be for dogs owned and handled in the ring by the breeder.

**OPEN CLASS** - shall be for all Dogs.

**SPECIALS ONLY** – Dogs which have a recorded CKC registration, Event Registration Number (ERN) or Miscellaneous Certification Number (MCN) and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship

The following classes will be provided, divided by sex. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

### **NON-REGULAR CLASSES**

**VETERAN CLASS** - In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran Best Veteran in Breed Best Veteran in Group Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

**BABY PUPPY CLASS** – Dogs 3 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

**ALTERED:** Altered will be divided Males and Females with a Best of Breed judged for each. The Best of Breed winner will go on to Best Altered in Group and Best Altered in Show. All dogs must be surgically altered to enter this show.

**EXHIBITION ONLY** - Dogs entered in this class may not compete in the regular breed classes.

entry form. All dogs entered in this class shall be listed in the catalogue with the same particulars as for a dog entered for competition. No dog so entered can compete in any Regular class, however it may be entered in and compete in any Unofficial Class. A listing fee is not required for a listed dog entered in Exhibition Only (not entered for any competition).



## **CHAMPIONSHIP POINTS**

**15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:**

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

15.1.9 A dog may not be credited with more than five (5) championship points in a single show.

15.1.10 Permission shall be granted to a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

15.1.11 A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

15.1.12 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges;

(b) be registered in the records of the CKC, have an Event Registration Number (ERN) or Miscellaneous Certification Number (MCN);

(c) have earned at least one 2-point win either at the breed or group level.

15.1.13 The Board interprets the words “earn at least 10 championship points under 3 different judges” to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge’s awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing.
