## WAIT LIST

Once a class and/or component limit is reached, entries will be assigned a position on a wait list. Where possible, spaces will be filled with a dog entering the same class. Those on the waitlist will be notified via email when a space becomes available. Payment required within 2 hours of being notified a space is available.

## **COMMUNICATIONS & JUDGING SCHEDULE**

All communications, including the Judging Schedule, will be emailed via Dogshow.ca.

Changes to the Judging Schedule after entries close are at the discretion of the event Secretary or Judge.

## WITHDRAWAL OF ENTRIES & REFUNDS

An entry can be withdrawn before entries close by notifying the event Secretary. Refunds will only be issued if the event Secretary receives notice in writing of withdrawal before entries close.

> Pursuant to rule 4.4.2, no refunds after closing except in the following circumstances: 1. A bitch comes into season.

2. The event Secretary is notified in writing that a dog will be absent within 24 hours of the event and the space can be filled from the wait list.

## EVENT & ENTRY:

Entries limited to 7 dogs per component in each class.

No handler shall handle more than one dog in the same class.

Bitches in season are not permitted to compete. Refunds for a bitch in season will be issued in accordance with rule 6.5.2.

Day of event entries will be accepted if the limit has not been reached.

No change of entries or moving up after closing.

No resets.

No ribbons, rosettes, prizes or trophies will be awarded

### VENUE: Unbenched - Unexamined - No Indoor Benching - Bench at your vehicle

Stairs may be used to access a search area. The flooring is concrete or hardwood.

If a handler has a disability or a dog has a physical challenge that may require accommodation, please advise the event Secretary prior to entering so it can be determined if the disability/challenge can be accommodated.

Washroom facilities available on an intermittent basis.

No scent oils, scent aids or scent vessels allowed within the event precincts.

A warm-up area will be available in accordance with rule 9.5.2. Be courteous to exhibitors using or waiting to use the warm-up area.

No dog shall be off leash except in the designated search area while it is being judged in the competition.

It is within the judge's discretion to allow or disallow a dog to be off leash while searching. Violation of this rule or failure to follow the judge's direction may result in immediate removal.

#### The event precincts are the grounds of the DeWinton Community Hall, including all buildings and structures. Do not allow your dog to urinate or defecate on the building or structures. CLEAN UP AFTER YOURSELF AND YOUR DOG DON'T LITTER

### CKC SCENT DETECTION RULES & REGULATIONS Rule 6.6 - Health

6.6.1 No dog may be entered at a trial if it has any communicable disease.

6.6.2 Dogs entered in a test must have current immunization status\*.

6.6.3 No dog may be brought onto the grounds or premises of a trial if it:

(a) Is known to have distemper, parvovirus, kennel cough or other communicable disease, or (b) Has recovered from distemper, parvovirus, kennel cough or other communicable within the last 30 days.

(c) Has been housed within 30 days prior to the trial on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

6.6.4 Where it is found that these rules have been contravened, the dog in question shall be removed from the premises and the exhibitor/handler will be subject to disciplinary action.

### \*Exhibitors / Handlers are urged to carry proof of current immunization, or be able to easily obtain and produce it, in the event a dog's immunization status is questioned\*.

It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
