- ONLY APPROVED CKC collars will be allowed in the precincts of the Trials.

Continue on Highway 60 for 20 km. then turn left onto Churchill Avenue. Drive down Churchill Avenue for 600 meters (first intersection) and turn right onto Pippin Street. Pike Lake Community Hall is located approximately 2/3 of the way down this street or 170 meters on the left (between the Pike Lake Fire Hall and Pike Lake Community School).
